Subject: Appointments to the Youth Commission

Recommendation: It is recommended that the City Council adopt a resolution confirming the reappointment of four Youth Commissioners and the appointment of seven new members to the Youth Commission, as well as approve twelve alternates.

Background: Resolution No. 94-221, adopted October 4, 1994, provides for the seventeen member Youth Commission, nine to serve even-year terms and eight to serve odd-year terms. On April 30, 1998, a panel consisting of two members each from the City Council, Hayward Area Recreation and Park District Board, and the Hayward Unified School District Board conducted twenty interviews to fill seven vacancies to the Hayward Youth Commission. The panel recommended confirmation of four reappointments expiring June, 2000 and seven new members for appointment. Twelve students were nominated as alternates should it be necessary to fill a vacancy within the year. In summary:


