Adopt an ordinance introduced by Council Member Henson at a meeting of the Hayward City Council on July 21, 1998.


BACKGROUND:

COUNCIL OF THE CITY OF HAYWARD

AN ORDINANCE AMENDING THE CARD CLUB REGULATIONS OF THE CITY OF

THE CITY COUNCIL OF THE CITY OF HAYWARD DOES ORDAIN AS FOLLOWS:

Section 1. Section 4-3.18 of the Hayward Municipal Code is hereby amended to read:
