The ordinance was introduced at the February 6th meeting of the City Council with the following vote:



PUBLIC NOTICE OF AN INTRODUCTION OF AN ORDINANCE BY THE CITY  
COUNCIL OF THE CITY OF HAYWARD

AN ORDINANCE ADDING SECTIONS 7-2.70 THROUGH 7-2.83 TO  
CHAPTER 7, ARTICLE 2 OF THE HAYWARD MUNICIPAL CODE  
PERTAINING TO THE MAINTENANCE AND REPAIR OF SIDEWALKS

THE CITY COUNCIL OF THE CITY OF HAYWARD DOES ORDAIN AS FOLLOWS:

Section 1. Sections 7-2.70 through 7-2.83 of Chapter 7, Article 2 of the Hayward Municipal Code are hereby added to read in full as follows:

Section 2. In accordance with the provisions of Section 620 of the City Charter, this ordinance shall become effective 30 days from and after the date of its adoption.
