**TO:** Mayor and City Council

**SUBJECT:** New Sidewalk Construction 2003/04 – Portions of Soto Road, Orchard Avenue, Fifth Street, and "E" Street: Approval of Plans and Specifications and Call for Bids

**RECOMMENDATION:**

It is recommended that the City Council adopt the attached resolution that approves the plans and specifications for the New Sidewalk Construction 2003/04 project for portions of Soto Road, Orchard Avenue, Fifth Street, and "E" Street and calls for bids to be received on May 3, 2005.

**DISCUSSION:**

This project is a continuation of the program to construct new sidewalks on critical pedestrian pathways, specifically those associated with schools and other heavy use areas. The project will construct curb, gutter, sidewalk, and wheelchair ramps along Orchard Avenue, between Soto Road and Avocado Court; in front of 24628 Soto Road; along "E" Street, between Fifth Street and East Street; and along Fifth Street, between "D" Street and Markham Elementary School (see Exhibit A). Additionally, the project will install a storm drain inlet on Pleasant Way to accommodate storm runoff from the new curb and gutter.

The project is categorically exempt under the California Environmental Quality Act Guidelines, under the minor alteration of existing facilities.


**FUNDING:**

3. That the City Council will consider a report on the bids at a regular meeting following the aforesaid opening and declaration of same
4. That the City Clerk is hereby directed to cause a notice calling for bids for the required work and material to be made in the form and manner provided by law; and
5. That the project is categorically exempt under the California Environmental Quality Act Guidelines (CEQA) under the minor alterations of existing facilities.
