SUBJECT: Tobacco Control Enforcement Program

RECOMMENDATION:

It is recommended that the City Council adopt the attached resolution:

1. Authorizing the City Manager to execute an agreement with the County of Alameda to accept funding for the Tobacco Control Enforcement Grant, and
2. Appropriating \$15,000 to implement the grant program.

BACKGROUND:


On September 7, 2006, the Alameda County Health Department Tobacco Control Program awarded the Hayward Police Department \$15,000 to implement a Tobacco Control Program. The program will be staffed on an overtime basis by members of the Hayward Police Department.

The goals of the Tobacco Control Program are:

1. Provide complaint based enforcement of Labor Code §6404.5, regarding smoke-free workplace laws;
2. Provide education about and enforcement of Penal Code §308, regarding youth access to tobacco products; and
3. Monitor businesses for other tobacco related laws including counterfeit cigarette tax stamps.


The funding period for this grant is November 1, 2006, through May 31, 2007.



RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH THE COUNTY OF ALAMEDA TO ACCEPT FUNDING FOR THE TOBACCO CONTROL ENFORCEMENT GRANT; APPROPRIATION OF FUNDS
