**SUBJECT:** Appointments and Reappointments to Various Boards, Commissions, Committees, and Task Force

### **RECOMMENDATION**

That the City Council adopts the attached resolution confirming twenty-eight appointments to the Citizens Advisory Commission (7), Council Economic Development Committee (4), Downtown Business Improvement Area Advisory Board (4), Human Services Commission (1), the Keep Hayward Clean and Green Task Force (6), Library Commission (1), Personnel and Affirmative Action Commission (2), and Planning Commission (3). ### **BACKGROUND**


