What I have experienced last week is a home owner has again called the Police for the third time to stop me from doing what I have and <sup>had</sup> continued to do on the street and sidewalk near his house property. What I have or had been doing was to clean the street and sidewalk near and or in front of his house as in picking up trash and or remove certain plant(s) items that are invading, obstructing, hurting and or injuring side walkers on such sidewalk in front of his house property. What I had told such Police before this last time in last week as I have in the past was that what I am doing is pick up trash and address certain plants that are endangering the City Property and or our City Public Side Walkers just as various City Management Landscape and Sidewalk workers also have and continue to do so to help protect a or all People walking on our Public Sidewalks, Streets, Parking Lots, and or near Landscapes. What the Police Officer told me in this recent event last week was that what I and or such City Management Workers have and or do as in remove Private Owned Material or Items from any City Public Street Sidewalk is illegal if we do not get permission from the owner of such material so to be allowed to remove such material from A Cite Public Area, as such you are now sited for a violation of a law ~~which is illegal~~ and you are sentenced to go to Court to be judged for such illegal behavior.

Ouch; If I or when I go to such Court and become convicted I suspect I will lose some money and or also go to jail for some and or any time which I will in such time or soon after I will loose my car. Loosing money and or my car is very painful and bad to me because I am unemployed and homeless.

I suspect that you know and or remember that I am or have been homeless in Hayward for five years. Becoming homeless was and is somewhat painful to me and others that become homeless anywhere. What I have learned and experience within such time period of homeless in Hayward is that I can now greatly increase my volunteer work to continue to help protect our Hayward City Public Family Community for Us All People In Hayward. Also for instance as in the past I did volunteer work every week to help Educate, Protect People so to reduce and or Prevent People to become hurt every week in the recent past three decades in the East Bay and sometime in the West Bay.

If I am convicted of unknowingly violating such law as I <sup>HAVE BEEN</sup> helping to protect our Hayward City Public People, I will no longer be able to continue to help protect our Hayward City Public People and others located in Hayward as often and as greatly good as I have been able to do for the past five years in Hayward; ~~ouch!~~

What I experienced last week as I was cleaning a sidewalk stated before was that as I was walking on such sidewalk I noticed that one of the owners plants was grown bigger and blocking, endangering our Public more than before. Seeing that my reaction was to start removing such growing plants' items that increased blocking part of the sidewalk I became to remove such parts of the plant as removing about four inches of such material from the plant. I had cut off three plant items and then hired a man on the house property telling me to stop cutting his plants, hearing him and then seeing him I did stop. What he told me to do as he has told me before in the past was to leave this area. I told him as I have told him in the past that I am not going to leave this area because I am going to continue to help create, maintain and secure a safe Public Sidewalk to protect us all. Saying that again last week he again did not respond and no longer talk to me, as such I turned away from him to continue to walk on the sidewalk to clean more areas on the street. As I turned around and began to walk my face was subjected of a tree branch. My body's reaction was to grab such tree branch and begin to try to cut it off. Suddenly I heard that man tell me do not cut my plants, hearing that I did stop and began to tell him that I now know that you have witness and know that your plants have and can continue to hurt a person and or injure other people. His response to my comment was that he does not care, that says he does not care if or when his plants hurt me and or injure anyone. My response to that was: I said ouch, that indicates or documents that you are going to go to hell. As I was about to say ouch again he interrupted me and told me that he and I are both going to go to hell. My response to that was that no I am not going to go to hell because God has for decades supported me and worked with me to helped me to educate groups of people, and I suspect God will continue to support me and work with me to help educate people. Saying that he did not respond upon me, as such I backed up toward the street so to not get hurt by his plants and began to address more trash and or plants near other people's properties.

What I also experienced that day was as I saw a plant material much bigger than its other plants material I walk to it to cut it off. What I notice before I cut it off was that a person was standing in or on their property and was taking a picture of me. My response to that person was to say thank you for taking a picture of me because that helps to document that I help protect our Hayward public people from becoming subjected to disrespectful dangerous plant material located into or on Hayward Public Sidewalks, thank you. What I did then was cut off such Plants' branch and began to walk away to continue helping to protect our public. *about 15 minutes later a Police*

*officer parked near me and told me to stop, as I have told you at the beginning of these statements*
