**SUBJECT:** Direction To Staff Regarding Boards and Commission Recruitment

**RECOMMENDATION:**

It is requested that the City Council provide direction to staff regarding recruitment for Boards and Commissions.


**BACKGROUND:**

Presently, there are three vacancies on the City's Boards and Commissions with another seven additional vacancies to occur on June 30 due to members having served more than two terms or ten years (see attachment). Staff is requesting direction regarding the schedule for the recruitment process. Typically, the annual Boards and Commissions recruitment commences in the spring for 4-6 weeks, with the Council interviews scheduled about 10 days later. (Last year, the recruitment was extended through the summer months and interviews were held in September.) It is requested that the Council determine if a change in the typical schedule is in order. If the typical schedule is used, the recruitment could begin on May 15 and end on June 15 with interviews at the end of June.
