Service Start Up

Businesses may request service to collect co-mingled recyclables or organic materials by contacting Waste Management or the City.

To encourage participation in the program, indoor storage containers for recyclables and organic materials may be obtained from the City at no additional charge. Literature describing the proper preparation of materials will also be available for distribution to employees.

Two or more businesses may share use of a cart or bin for recyclable or organic materials.



COLLECTION OF CO-MINGLED RECYCLABLES

The recyclables listed below are acceptable using any of the following container sizes: 96-gallon carts, or 1, 2, 3, 4, 6, or 7 cubic-yard bins.

- corrugated cardboard
- newspaper
- white and colored paper, computer paper, envelopes, junk mail, magazines, catalogs, phone books
- aluminum, tin, and steel cans
- plastic containers marked ♻️ through ♻️ (clear polystyrene), or ♻️
- glass bottles and jars
- shrinkwrap (in clear, closed bag)



Unacceptable materials for co-mingled recycling include:

- ✗ Tissues, paper towels, detergent boxes
- ✗ Paper with plastic coating, wax-covered paper, foil-lined paper
- ✗ Tyvek® non-tearing paper envelopes
- ✗ Food-soiled paper and boxes; wax-covered cardboard
- ✗ Polystyrene foam containers of all shapes and colors



COLLECTION OF ORGANIC MATERIALS

Listed below are acceptable organic materials and collection rates. Rates are 50% of monthly garbage rates for the same level of service.

- food-soiled paper, paper towels, and boxes
- food scraps
- grass, leaves, flowers, trimmings
- unpainted, untreated wood

Unacceptable materials for organic recycling include:

- ✗ Glass or metals of any kind
- ✗ Cooking grease
- ✗ Plastic of any kind (e.g. film, packaging)
- ✗ Particle board, plywood, painted or treated wood

NEW CITY OF HAYWARD ORDINANCE

Beginning July 1, 2011, all retail food providers in Hayward must use paper, aluminum or recyclable plastic food service containers. Vendors include: restaurants, delicatessens, shops, supermarkets, cafeterias, retail food vendors, sales outlets, caterers, catering trucks or vehicles, farmers' markets, sidewalk or other vendors.



Polystyrene foam containers, of all shapes, including plates, cups, bowls, trays, and hinged and lidded containers.



Paper (including wax-covered paper), cardboard, aluminum, glass, plastic containers with a resin number ♻️ through ♻️ (clear polystyrene), or ♻️ are acceptable.



NOTE: Utensils, straws, and lids are not subject to the ordinance.
